The brief fact of the case is that the Company namely M/s Adarsh Developers is a premier real estate developer, located outside Bangalore. From past 36 yrs the said company is engaged in developing landmark residential, commercial and hospitality projects across Bangalore. The company has 1800 employees on its rolls and over 10,000 laborers through various contactors in 35 plus residential projects across Bangalore with turnover of 2,100 Cr for the FY 2023-24. For storage of company's financial data and customers' personal data the company was using SAP ERP stored with Amazon cloud Services. On the other hand on May 2023 Mr Saidalawi Safan who is Business Development Representative from Amazon Web Services (AWS) contacted the company and insisted to use their cloud storage servers assuring retrieval of data even in the events of cyber terrorism or act of sabotage or other events like lightning, earthquake, cyclone, flood, storms etc. Believing such assurance in the month of December 2023 the company procured with cloud storage facilities with AWS through SAP implementation partner M/S SAVIC Technologies Pvt Ltd, Mumbai. and work order was issued to them to shift the company's data from earlier cloud storage facility to Amazon Web Services and also to maintain the data securely for 3 yrs until November 2027 and the payment was agreed for 88,59,924/- Rs including GST.

However on 9th January 2025 at 10.48 Am, the entire SAP S/4HANA environment hosted on AWS was completely deleted on contacting the SAVIC Technologies Pvt Ltd company conveyed that due to the actions of few individuals at Redington and AWS teams, there has been a data loss and further told that employees at Redington Group have entered into our storage area at root level and deleted our account completely. This event has resulted in the loss of over six years of company business data causing substantial financial and operational loss to the company. The deletion of SAP S/4HANA has made the business functions/operations complete halt and the vital financial records, supply chain data, customer information and operational insights accumulated over years which are now is inaccessible. The value of data loss is around 150 crores where the company is unable to collect payments from customers, unable to pay statutory taxes, interest payments to lenders which caused approximately a loss of 5

crores per day starting from 9th January 2025 till date and total loss estimated to 150 cr as on 31st January 2025. In this regard the Amazon web Services India has replied stating despite their best efforts they are unable to retrieve the data and unable to restore it. Hence the complaint was given to take necessary legal action against the culprits and do the needful.
